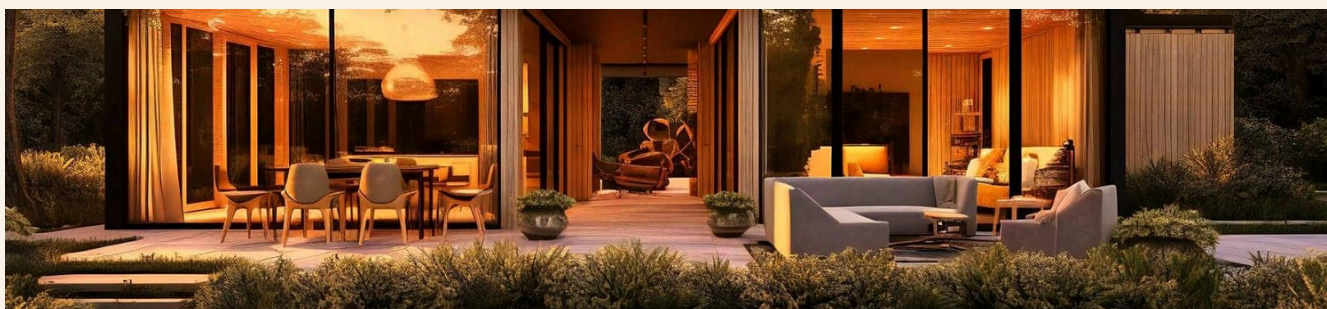

- ◆ **NRI-friendly** — passport KYC, NRE/NRO payments, remote registry
- ◆ **Buyback is not market risk** — the value is pre-agreed in your agreement
